THE CAADP-XP4 PROGRAMME

The comprehensive Africa Agriculture Development Programme X Pillar 4(CAADP-XP4) project under the DeSIRA program is finance by the European Union and managed by the International Fund for Agricultural Development (IFAD). It is a four-years project (2019-2023), with interventions to support a science and innovation led and climate relevant agricultural transformation in Africa.

UFAAS is one of the AFAAS Country Chapters, that is implementing CAADP-XP4 and under this, a Technical Working Group (TWG) on Climate Smart Agriculture (CSA)was formed in 2019. The key activities implemented under CAADPX-P4 are:

Enhancing the scalability of CSA among AEAS actors in Uganda, during Covid -19. The key activities included mapping of 65 CSA initiatives: profiling of CSA activities of member organizations, capturing 12 case stories on climate smart activities at farmer level and development of various CSA knowledge products. (CAADPXP4).

Digitalization of Climate Smart Agriculture Project: UFAAS was among the ten (10) Country Chapters that was supported together to participate in the AFAAS Country Hackathon 2021 and other related activities, in order to put more effort in digitalization of Climate Smart Agriculture (CSA). The activities included:

Supporting the organising of Hackathon at national level

"UFAAS Hackathon 2021" was organized by UFAAS and Dostrim Limited – an ICT firm and the key themes were:

- Theme #1- Management of AEAS actors' database and activities
- Theme #2-Database of CSA techniques, approaches and knowledge:
- Theme #3- Meteorological and weather information systems coupled with crop calendar.

- Promotion of usage of digital tools in CSA
- Production of CSA knowledge products
- Strengthening of CSA TWG & knowledge.

Advocating for Climate Smart Agriculture; National and Regional Stakeholder Dialogue on CSA:

Recommendations from the dialogues

A proper coordination mechanism to promote synergies among AEAS actors across all levels.

- A National Steering Committee to follow up on the designated climate change taskforce of the Ministry of Agriculture, Animall Industry and Fisheries (MAAIF)and facilitate transitioning to full functionality with CSA approach.
- Need to adopt a framework for joint planning and implementation in order to coordinate and mainstream CSA.
- Local government and other stake holders need to empower communities in collective action that is content specific so as to guard the dwindling of the country natural resources and also enforce adherence to law/ordinances.
- Campaigns for sensitizing and increasing uptake of the CSA initiatives at all levels, should include others such as schools, culture and religious establishments.

CSA INTERVENTIONS WITH OTHER PARTNERS SINCE 2019

A Study "Analyzing and prioritizing climate change related capacities and needs of national and subnational extension actors in Uganda" (with support from AFAAS and FAO). The key issue identified about the capacities and needs of the extension actors were; lack of accurate climate information, equipment and materials, field facilitation and planning process and their avaialability and confidence to address related issues.
